**Tau.** Txhiab leej neeg nyob hauv Minnesota muaj mob qaug dab peg tsav tsheb xuum xim tau thiab kuj tsis muaj teeb meem. ### **TXOJ KEV CAI RAU TUS TSAV TSHEB NTHUAV QHIA TXOG QAUG DAB PEG MUS RAU TOM DEPARTMENT OF PUBLIC SAFETY YOG LI CAS?**

Tus tsav tsheb yuav tau toob kas nthuav txog mob qaug dab peg, thiab hnuv tim qhov qaub dab peg tshwm sim, mus rau lub koob huam ntawm peb caug (30) hnuv uas muaj qaug dab peg. ## LUB SIB HAWM NCUA TOM QAB UAS QAUG DAB PEG YOG NTEV LI CAS?

Tom qab ua qaug dab peg lawm tus neeg tsav tsheb yuav tsum tsis muaj qaug dab peg ntxiv li peb (3) lub hli tso nws mam tau nws daim ntawv tsav tsheb rov qab. Yuav tau toob kas tus kws kho mob daim ntawv tso cai mus rau tom DVS (chaw ua ntaub ntawv tsav tsheb) tom qab peb (3) lub hli.

## PUAS MUAJ QHOV ZAM PUB TAU RAU LUB SIB HAWM PEB LUB HLI?

### **Muaj.**

1. Kev zam pub muaj ib zaug txhua plaub lub (4) xyoos twg yog tias 1) tus neeg tsav tsheb muaj tus mob qaug dab peg ua los ntawm ntu zus los sis 2) ib qho teeb meem uas tsis yoog raws li kev cai noj tshuaj (yog tias tus kws kho mob sau qhia pab rau qhov raug mob uas muaj luv thiab ntev los lawm). Qaug dab peg zaum ob nyob rau hauv plaub (4) lub xyoo yuav tsum tau sau ntawv rau Department of Public Safety's Medical Review Board kom tau kev pauv kev cais.
2. Yog tias qaug dab peg tshwm sim ntawm tus kws kho mob qhuab qhias kom pauv tshuaj los sis tsum tshuaj (thiab tus kws kho mob tsis pom zoo tshem kev tshav tsheb) yog ib qho kev zam pub tau. Diam ntawb ntawv los ntawm kws kho mob yuav tsum toob kas thaum rau (6) lub hli thiab 1 xyoo.
3. Yog tias tus kws khob mob sau tseg tias qhov qaub dab peg yog thawj zaug mob rau tus neeg tsav tsheb (thiab tus kws kho mob tsis tso cai tshem kev tshav tsheb) yog ib qho kev zam pub tau.

## DAIM NTAWV TSAV TSHEB NCUA NTEV TSHAJ PEB LUB HLI PUAS MUAJ?

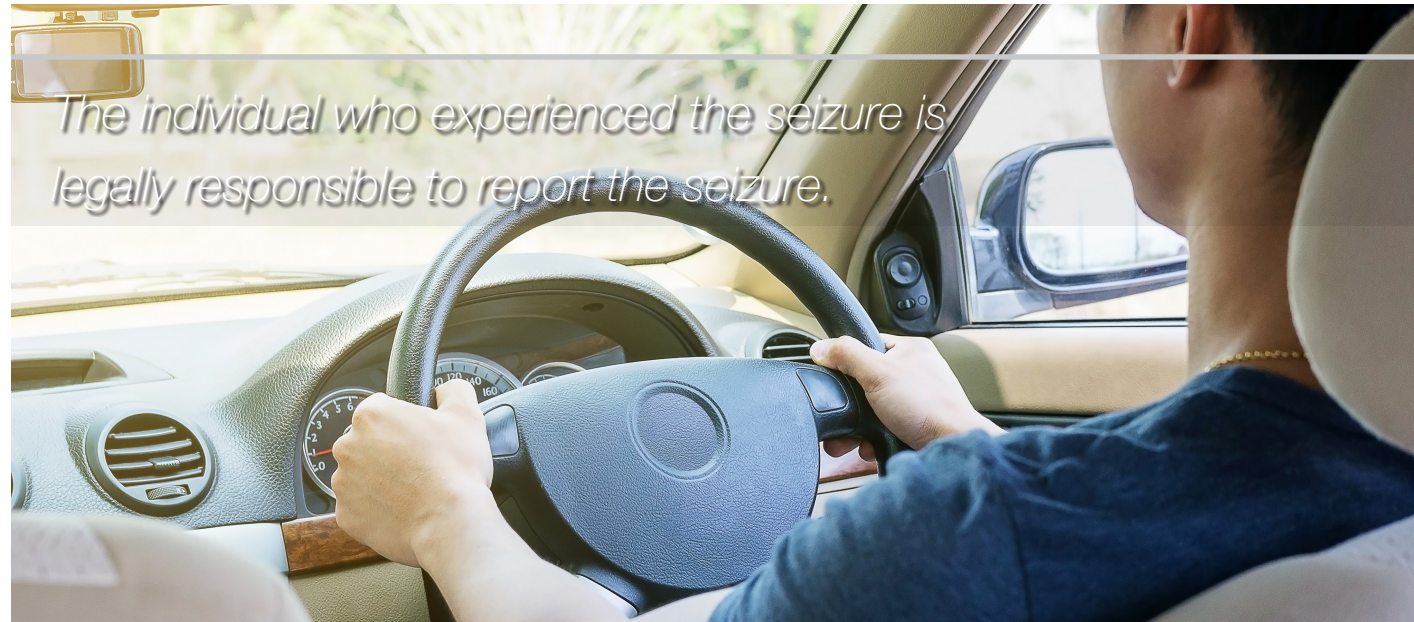

## YOG TIAS TUS KHEEJ MUAJ QAUG DAB PEG THAUM TSAUG ZOG ("NOCTURNAL"), PUAS YUAV TAU NTHUAV QHIA THIAB?

**Yuav tsum qhia,** Qhov xwm ntawm tus neeg uas mob qaug dab peg kuj pauv tau thiab. Tus neeg ib txwm tsis qaug dab peg thaum sawv ho kuj cia li muaj qaug dab peg thaum sawv muaj tau thiab. Tsis tas li, yog hais tias tus neeg uas qaug dab peg thaum tsaug zog tau tsaug zog thaum tsav tsheb los sis qaub zog, kev qaug dab peg kuj tshwm sim tau.

## IB TUG NEEG YWS PLAUB NTAWM KEV NCUA QHOV TSAV TSHEB PUAS TAU YOG TIAS NWS XAV HAIS TIAS NWS MUAJ FEEM LOS TSAV TSHEB?

## LEEJ TWG YOG TUS NTHUAV QHIA TXOG QHOV QAUG DAB PEG MUS RAU DEPARTMENT OF PUBLIC SAFETY? PUAS YOG TUS KWS KHOB MOB LUB LUAG HAUJ LWM?

**Tsis yog.** Tsis yog tus kws kho mob lub luag hauj lwm los nthuav qhia txog tus neeg mob kev qaug dab peg, tab sis tus kws kho mob kuj txiav txim siab qhia tau yog tias nws ntsua tau tias tus neeg mob tseem tsav tsheb. Raws li txoj cai yog tus neeg uas muaj mob qaug dab peg yuav tsum nthuav qhia txog nws tus mob qaug dab peg. Yog tsis nthuav qhia raw kev cai nws kuj tsis tau tshav tshev li peb (3) hli tom qab lawv paub txog.
